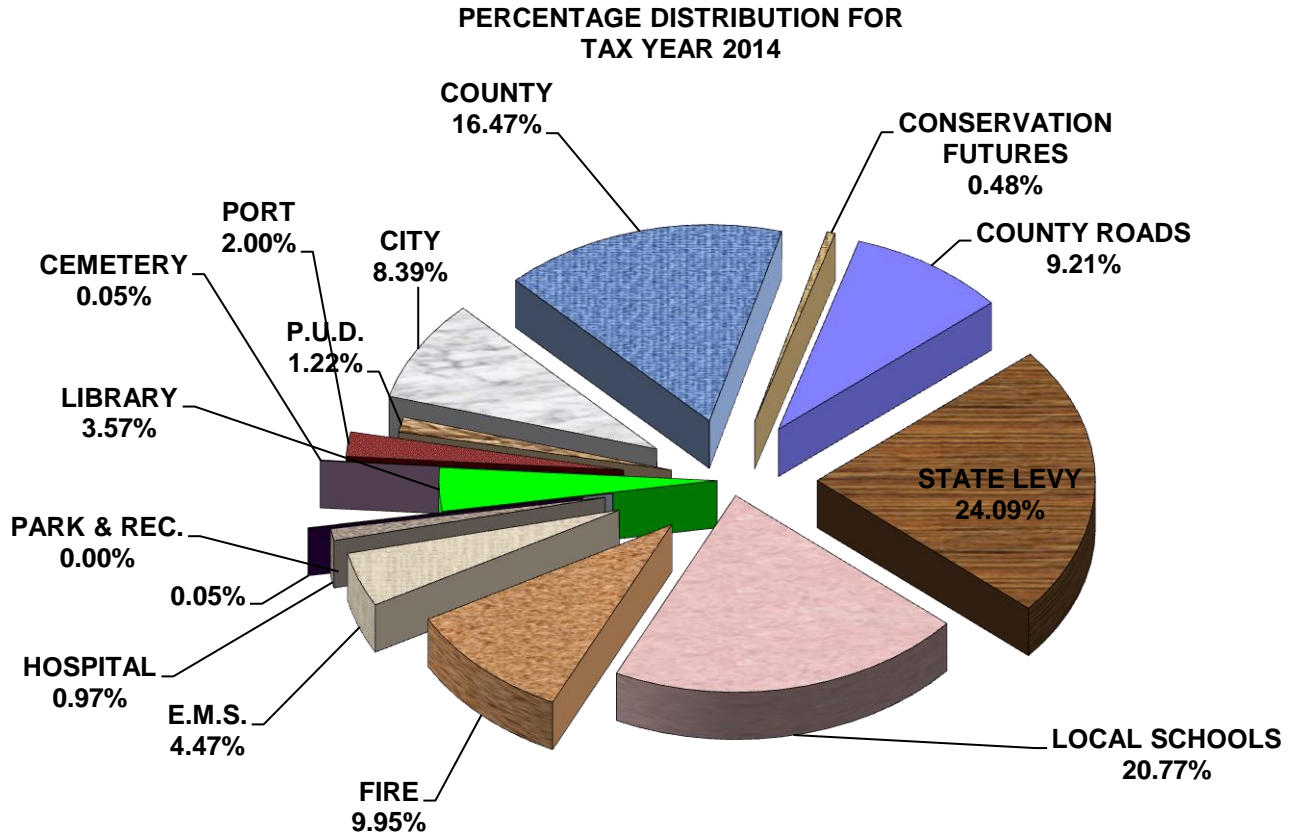

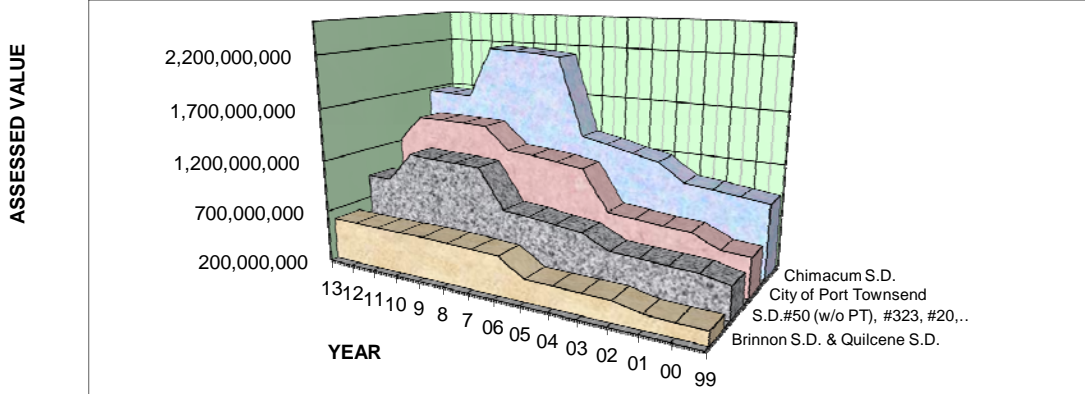

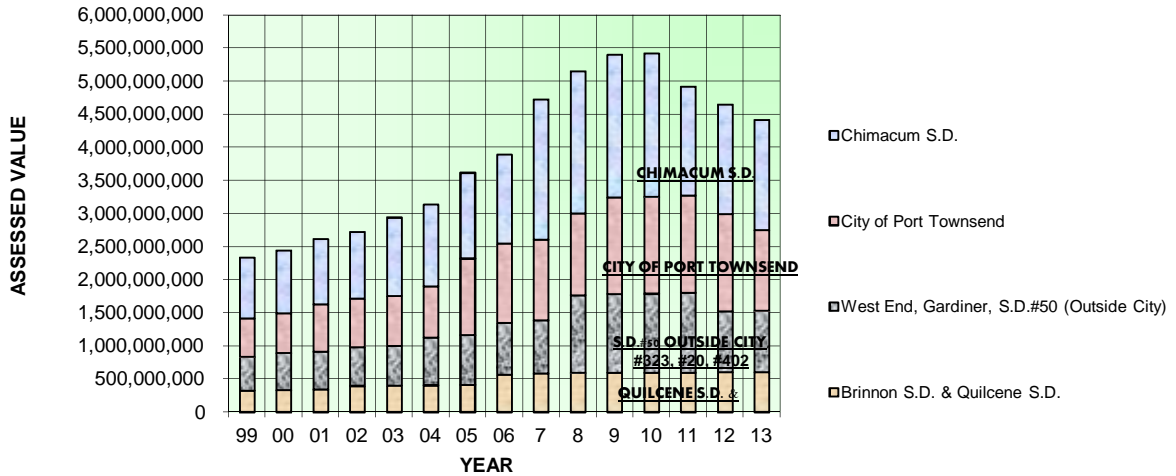

1999 to 2013

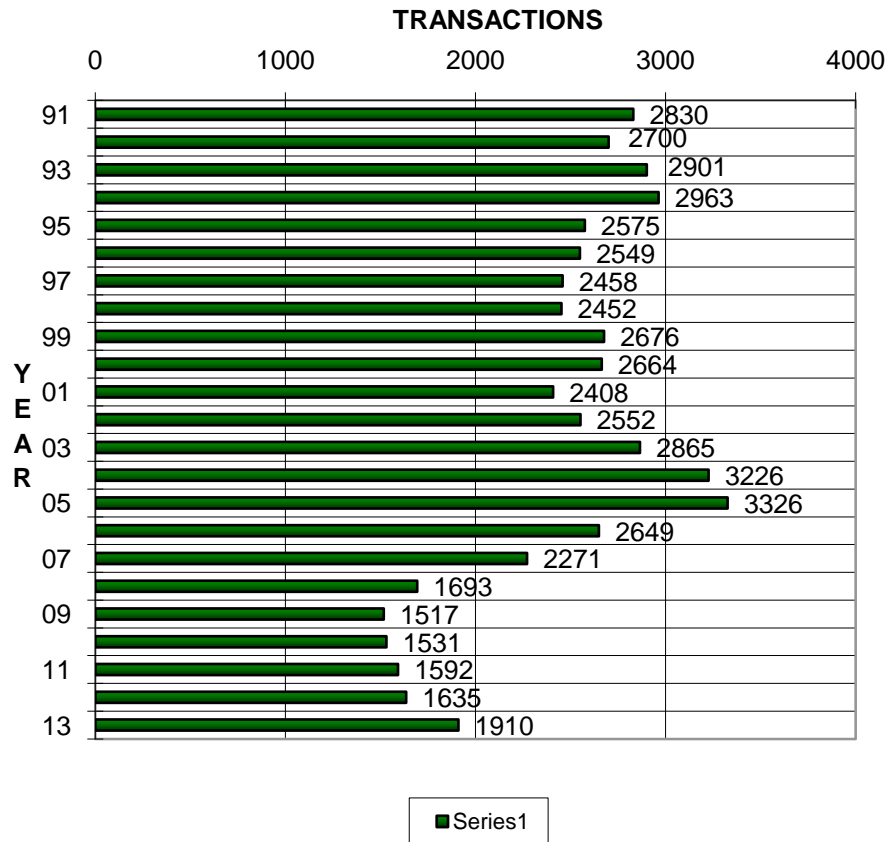

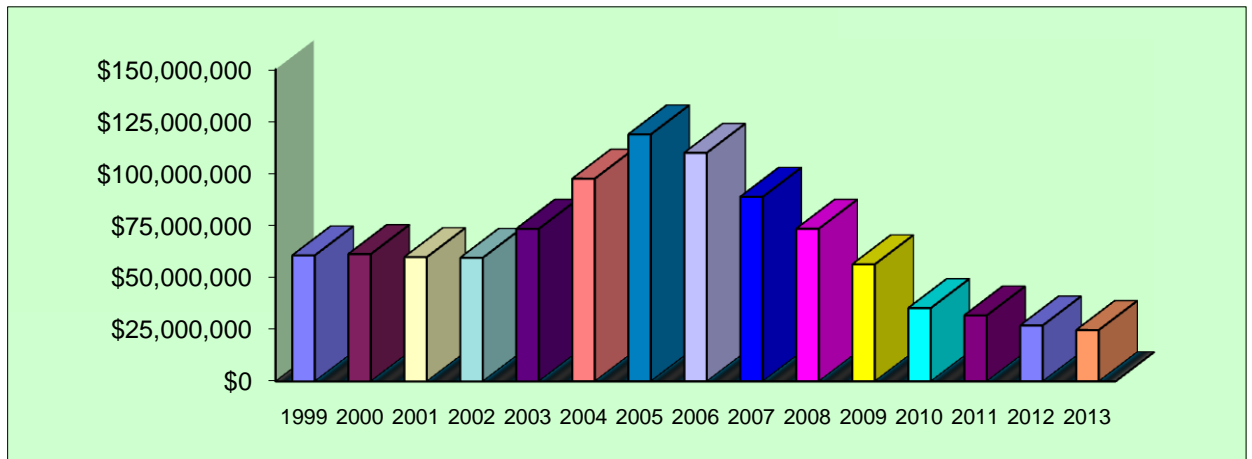
