☐ Need Table of Contents or some early indication in the chapter to show where the goals are located. The goals are not directly connected to the text. Need concrete connection, less abstraction.
☐ There's a contradiction between the goal of creating higher density and with the amount of low density zoning seen on Table 2-1a, p. 2-11.
☐ Increase the amount of High density zoning in the urban core.
☐ Define the urban core and plan around that.
☐ Multimodal transportation—walking, bicycles, etc.
☐ Concerns with the amount of traffic signaling and traffic lanes shown in Table 2-3 UGA Transportation Improvements. Reduce signalization and use round-abouts on thoroughfares.

Page 5-14 HSP 2.4 Reword text so the sentence reads: "Continue to improve processes that will allow for timely development efforts."
HSP 2.5 Revisit this policy and the idea of ADUs.
HSP 2.6 Reword text so the sentence reads: "Maintain a county impact fee program based on a fair share of the cost of new public facilities needed to accommodate each development project."
HSP 2.7 Just keep the first Sentence and consider making the second sentence a separate policy.
HSP 2.8 Reword text so the sentence reads: "Establish building codes to exploit benefits of all technologies that would contribute to minimizing environmental impacts, such as composting toilets, holding tanks and gray water systems."
HSP 2.9 Consider deleting this Policy.
HSG 3.0 Reword the text so the sentence reads: "Develop partnerships to create programs that will maintain, improve and increase affordable housing in the county."
HSP 3.1 Delete the words "the expansion of existing" so the sentence reads: "Support weatherization and energy conservation activities and programs."

HSP 4.1 Consider replacing this policy with HSP 4.2 (Henry)
Page 5.15 <i>HSP 4.2</i> – While it is true that we would wish to do what is stated for "special needs" populations, we do not specifically recognize elsewhere the value of "rehabilitation and adaptation of housing" as being (perhaps) more important than the development of new housing. I think the value of "rehabilitation and adaptation of housing" needs to appear as a policy under HSG 3.0 (p 5-16) or in a re-write of the goal, itself.
HSP 4.3 "Wordsmithing" policy so that sentence to read: "Support the development of special needs housing with social service providers and the public agencies that provide services and funding."
HSP 4.4 Remove text identifying specific entities so the sentence reads: "Coordinate with public and private housing interests to ensure that low income and special needs housing is sited in locations that are served by necessary support facilities and infrastructures."
HSP 4.6 Reword text so sentence reads: "Support the provisions of the Federal Fair Housing Act to accommodate disabled persons in Jefferson County."

	HSP 4.7 The last sentence seems to have the language of an ordinance and is not appropriate for a policy. Consider relocating this policy into section 2 and rewording text so the sentence reads: "Consider vacant public lands to accommodate low income housing opportunities throughout Jefferson County."
	p. 5-15 <i>HSP 4-17</i> – the "Joint County-City Housing Advisory Committee" has completed its study and the results should be appropriately incorporated in the Comp Plan.
	Page 5-16 Additional comments on "STRATAGIES": It was noted that the Housing Action Plan Network (HAPN) may have addressed many of the strategies. Suggested needed text to clarify item # 6
	"Consider" is not the correct word for a strategy.
	The issue is regarding the permitting of the occupancy of a dwelling where the mechanical, electrical, water, and septic are approved as safe but additional finish work remains. The strategy should be to develop an ordinance that will let that occur.
	There also was discussion that further review and changes would be needed to bring the text providing the background for the HOUSING ELEMENT more current, including the Tables 5-1 through 5.5.
