PUBLIC MEETINGS  
SHORELINE POLICY ADVISORY COMMITTEE**

NOTICE IS HEREBY GIVEN that the Jefferson County Shoreline Policy Advisory Committee (SPAC) will hold its first 3 regularly scheduled meetings at approximate two week intervals beginning on **Thursday, August 31, at 1:00 p.m.** at the Jefferson County Library, Humphrey Room, 620 Cedar Ave, Port Hadlock, WA. The second and third meetings will both be held at the WSU Learning Center, Spruce Room, Shold Business Park, 201 W. Patison, Port Hadlock on **Tuesday, September 12, at 10:00 am** and **Tuesday, September 26, at 10:00 am**. The meetings are open to the public. The committee consists of citizen stakeholders from the community representing various interest sectors along with representatives of local governmental entities, state agencies and tribal co-managers. The committee is expected to meet in preparation for participating in the Shoreline Charrette, October 12 - 17.

The SPAC's ongoing agenda is to utilize the scientific information prepared by project staff, consultants and the Shoreline Technical Advisory Committee as the basis for providing input to the development of proposed goals, policies, environment designations and regulations for a comprehensive update of the Jefferson County Shoreline Management Program (SMP). The SMP update is mandated by Washington State's Shoreline Management Act (RCW 90.58) and the 2003 SMP Guidelines (Chapter 173-26 WAC). Planning Commission recommendation, Board of County Commissioners review, and subsequent submittal to Washington Department of Ecology is expected to be complete by June 30, 2007.

Meeting topics will be listed in the Government Meetings section of the Port Townsend & Jefferson County Leader and in the Eye on Jefferson section of the Peninsula Daily News. The Forks Forum may also list the meeting notices in their Community News section.
