Statement of Issue: The Board is asked to approve the Call for Bids for the Dismal Creek Culvert Replacement, Upper Hoh Road M.P. 9.19, County Project No. XO1736.


Analysis/Strategic Goals/Pro's & Con's: Emergency repairs were completed at Upper Hoh Road M.P. 4.0 in March, 2007, with construction of 400 lineal feet of armored bank protection. Remaining work consists of mitigation as required by the Washington State Dept. of Fish & Wildlife (WDFW). Mitigation will be satisfied by replacing the fish-passage barrier culvert at Dismal Creek, Upper Hoh Road MP 9.19, with a 3-sided concrete box culvert. This Call for Bids is for the replacement of the culvert at Dismal Creek.

Fiscal Impact/Cost Benefit Analysis: The Engineer's estimate is \$415,239. This will be funded at 86.5% by the Federal Highway Administration, and 13.5% by County road funds.


Recommendation: The Board is requested to sign the Call for Bids and return to Public Works.

**Dismal Creek Culvert Replacement

Notice is hereby given that the Board of County Commissioners of Jefferson County, State of Washington, will receive sealed bids up until the hour of **9:30 a.m. on Monday, April 25, 2011** at the Office of the County Commissioners, basement level of the Jefferson County Courthouse, 1820 Jefferson Street, P.O. Box 1220, Port Townsend, Washington, 98368, for construction of the Dismal Creek Culvert Replacement, County Project No. XO1736. Sealed bids will be opened and read publicly at **10:00 a.m., or shortly thereafter**, on the same day in the Jefferson County Commissioners Chambers, basement level of the Jefferson County Courthouse.

This contract provides for the replacement of the culvert at Dismal Creek, at mile post 9.19 on the Upper Hoh Road, off of State Highway 101 near Forks WA. Work includes furnishing and installing a new 22 ft. span precast, reinforced, 3-sided box culvert with precast footings and precast wingwalls, constructing and removing a temporary traffic bypass, stream restoration, repaving, guardrails, site restoration, and other work, all in accordance with the attached Contract Plans, these Contract Provisions, and the Standard Specifications. This contract has construction timing restrictions.

Bids shall be submitted in accordance with the plans and specifications on file at the Department of Public Works, 623 Sheridan Street, Port Townsend, Washington, where copies may be obtained by prospective bidders. Hard copies and/or electronic copies may also be obtained by calling the Department of Public Works at (360) 385-9160.

Each bid shall be accompanied by a surety bond, postal money order, cash, cashiers check or certified check payable to the Treasurer of Jefferson County in the sum of five (5%) percent of the bid amount, to be forfeited to Jefferson County by the successful bidder if he/she fails to enter into a contract and file an acceptable surety bond in the amount of 100% of the contract price within ten (10) days of the award. The Board of County Commissioners reserves the right to reject any and all bids, and to accept the bid deemed most advantageous to Jefferson County, and to waive all informalities in the bidding.

Jefferson County, in accordance with Title VI of the Civil Rights Act of 1964, 78 Stat. 252, 42 U.S.C. 2000d to 2000-4 and Title 49, Code of Federal Regulations, Department of Transportation, Subtitle A, Office of the Secretary, Part 21, nondiscrimination in federally assisted programs of the Department of Transportation issued pursuant to such Act, hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color or national origin in consideration for an award.
