Fiscal Impact/Cost Benefit Analysis:


The Architect's estimate for this work is \$220,000. This project is funded through a combination of budgeted County funds and a Washington State Historic Courthouse Grant.

Notice is hereby given that the Board of County Commissioners of Jefferson County, State of Washington, will receive SEALED BIDS for:

Jefferson County Courthouse Roof Stabilization Project

Bids will be received up until the hour of 9:30 a.m. Monday, **July 11, 2011**, at the office of the County Commissioners, basement floor of the Jefferson County Courthouse, 1820 Jefferson Street, P.O. Box 1220, Port Townsend, Washington, 98368. Sealed bids will be opened and read publicly at 10:00 a.m., or shortly after, on the same day at the Jefferson County Commissioners Chambers, basement floor of the Jefferson County Courthouse.

This contract is to supply all labor, equipment and materials necessary to complete repairs and upgrades to the main roof structure of the Jefferson County Courthouse, a National Historic Landmark. This work includes, but is not limited to, stabilization of a brick masonry chimney, brick masonry walls, the rehabilitation of built-in copper gutters and flashing, construction of wood framed diaphragms, and anchoring of wood framing to brick masonry. This work is to be completed on the fully operational Courthouse which is located within a residential neighborhood. The Architect's estimate for the Base Bid is \$220,000.

Bids shall be submitted in accordance with the provisions of the bid documents on which can be reviewed at or obtained from the office of: Jefferson County Department of Public Works, 623 Sheridan Street, Port Townsend, Washington, 98368, (360-385-9160). **Bid packages will be available on Monday, June 20, 2011.** There is a non-refundable fee of \$50.00. Bid Documents are also available via the internet at bxwa.com. A one-time only, non-mandatory, Pre-Bid Walk-Thru is scheduled for June 30, 2011, meet at 9:00 a.m. at the first floor Courthouse Lobby.

Each Bid shall be accompanied by a surety bond, postal money order, cash, cashier's check, or certified check in the sum of 5% of the bid amount, to be forfeited to Jefferson County by the successful bidder if he fails to enter into a contract and file and acceptable surety bond in the amount of 100% of the contract price within ten (10) days of the award.

It will be the sole responsibility of the bidder to ensure bids are in the possession of the Board of County Commissioners by the appointed date and time. No facsimile bid documents will be accepted. The Board of County Commissioners reserves the right to reject any and all proposals and to accept the proposals deemed most advantageous to Jefferson County and to waive all informalities in the bidding.
