WHEREAS, the Jefferson County Board of Commissioners has reviewed a road vacation petition submitted by James Burnell and Andrea Vitalich; and

WHEREAS, the Jefferson County Hearing Examiner held a public hearing on the road vacation petition on March 22, 2011; and

WHEREAS, the Jefferson County Hearing Examiner considered testimony of the public, comments from applicable departments, agencies and offices, and recommendations from the Jefferson County Engineer at the public hearing; and

WHEREAS, the Jefferson County Hearing Examiner determined that the vacation complies with the Jefferson County Comprehensive Plan and other applicable plans, policies or ordinances; and

WHEREAS, the Jefferson County Board of Commissioners considered said Hearing Examiner's report of the public hearing and his recommendation for the vacation request at a regularly scheduled Board meeting on June 20, 2011; and

WHEREAS, sufficient written evidence was submitted to indicate that there is no opposition to this vacation from adjacent property owners; and

WHEREAS, the petitioner has paid all administrative costs associated with the road vacation and,

WHEREAS, the county does not hold title to this right of way through a dedication and therefore base payment for the area to be vacated is not required; and

WHEREAS, public expenditures made in the improvement and maintenance of this portion of road are negligible and therefore no payment is required;

NOW, THEREFORE BE IT RESOLVED, that the following be vacated and abandoned pursuant to RCW 36.87 and JCC 12.10: all that portion of the westerly 184 feet of Mumby Road, CR #596609, reducing the overall County Road Log length from 0.613 miles to 0.578 miles beginning at the intersection with Flagler Road, also known as SR 116 at MP 9.33 left. Said usage right of way is located in the South 200 feet of the North 450 feet of Gov't Lot 1, Section 20, Township 30 North, Range 1 East, W.M., Jefferson County, Washington. This vacation affects parcel number: 021202012.
