Subject: Schedule a public hearing date for the proposed 2013-2018 Six-Year Transportation Improvement Program (6-yr TIP) and proposed amendments to the existing 2012-2017 TIP

Statement of Issue:

Schedule a public hearing for 10:00 AM on Monday, August 13, 2012 for the purpose of receiving public testimony concerning adoption of the 2013-2018 Jefferson County Six-Year Transportation Improvement Program (6-yr TIP) and proposed amendments to the existing 2012-2017 TIP.

RCW 36.81.121 obligates the legislative authority of each county in the state to adopt on an annual basis a 6-yr TIP, holding a public hearing prior to adoption. Public Works prepares a proposed 6-yr TIP and adopting Resolution for Board consideration. These will be submitted with a Regular Agenda Request prior to the public hearing.

The Board is requested to set the hearing date and sign the legal notice to enable it to be published prior to the hearing.
