Additional funds are needed to fulfill 2012 expenditures. This additional amount was approved by the County Commissioners during the 3rd Quarter Budget Appropriation Process.



CONTRACT AMENDMENT #1
AGREEMENT
By and Between
FORKS CHAMBER OF COMMERCE
And
JEFFERSON COUNTY
For Hotel-Motel Funding 2012

This Amendment #1 is by and between JEFFERSON COUNTY (hereinafter known as "COUNTY") and the FORKS CHAMBER OF COMMERCE (hereinafter known as "FCC").

WHEREAS, the COUNTY and the FCC entered into an Agreement on March 26, 2012 for Hotel-Motel Funding in 2012; and

WHEREAS, the parties desire to amend the terms of that Agreement; and

WHEREAS, on May 18, 2012 the Jefferson County Lodging Tax Advisory Committee (LTAC) was advised that additional Lodging Tax revenue was projected to be available for appropriation in 2012 without reducing historic fund balances; and

WHEREAS, the LTAC reviewed and recommended \$3,955 in additional funding be awarded to the FCC to support greater delivery of services under the Agreement;

NOW, THEREFORE, IT IS AGREED BETWEEN BOTH PARTIES AS NAMED HEREIN that the Agreement executed on March 26, 2012 is hereby amended as follows:

1. An additional amount of \$3,955 will be paid in a lump sum to the FCC upon execution of this Amendment for the performance of the services specified in Section 1: SERVICES TO BE PERFORMED of the original Agreement executed on March 26, 2012.
2. The total 2012 Hotel-Motel amount will not exceed \$27,275.
3. All other terms and conditions of the original Agreement executed on March 26, 2012 will remain the same.
