**STATEMENT OF ISSUE:** State vs. Michael Pierce had venue changed from Jefferson County to Kitsap County for trial purposes. It was understood at all times that Jefferson County would be liable for jury fees and administrative costs.

**ANALYSIS:** The 3<sup>rd</sup> jury trial for State vs. Michael Pierce resulted in a mistrial. Jefferson County owes the Kitsap County Clerk's Office \$8696.02 for jury fees and administrative costs.


**FISCAL IMPACT:** \$8696.02 Expenditure

MEMORANDUM OF UNDERSTANDING

Additionally, Jefferson County will pay the Kitsap County Clerk \$100.00 per week for any portion of a week as full payment for all attendant administrative costs including, but not limited to, processing the additional summons, attending to jurors each day, tracking time in and out for jurors and managing juror payments.
