Highlights from Tuesday's Commissioner Meeting

May 30, 2007

PUBLIC COMMENT PERIOD: The following comments were made by citizens: A junk car has been abandoned on some County property in Quilcene; the Quilcene water system requires a reservoir for the fire hydrants; the availability of \$30 coupons to clean up junk cars should be publicized more in order for people to take advantage of it; there is a rumor that the County's General Fund reserves have declined this year, and people are saying that it is only a matter of time before Port Townsend Paper Company closes the mill; a constituent thanked the Board for doing a good job; and concerns were expressed about the responsibility and process for bonding newly elected officials.

PLANNING COMMISSION RECOMMEND-ATION REGARDING UGA: The Planning Commission held a public hearing on proposed revisions to the Comprehensive Plan and UDC amendments regarding the Irondale/Port Hadlock UGA that will bring the County into compliance with three Western Washington Growth Management Hearings Board orders. The Board reveiwed their recommendation and a draft ordinance that still needs review by the Deputy Prosecuting Attorney. If the Board accepts the Planning Commission's recommendation, another public hearing will not be necessary.

PUBLIC INFRASTRUCTURE FUND BOARD APPOINTMENT: The Board appointed Bill Irwin to represent Commissioner District 3 on the PIF Board in place of Kathleen Emmerson.
