

**NOTICE OF PUBLIC HEARING:
WAVEDIVISION I, LLC
CABLE TV & TELECOMMUNICATIONS FRANCHISE**

Notice is hereby given that the Jefferson County Board of Commissioners will conduct a public hearing on Monday February 6, 2012 at 10:00 AM in the Commissioners' Chambers at the Jefferson County Courthouse, 1820 Jefferson Street, Port Townsend, Washington, to take testimony concerning a proposed Resolution granting a nonexclusive, temporary franchise to WaveDivision I, LLC to construct, maintain, and operate cable TV and telecommunications transmission and distribution facilities within County Road rights-of-way located in the following Townships (T), Ranges (R), and Sections (S) in the easterly portion of unincorporated Jefferson County: T 25 North, R 1 West, S 2-5; T 25 North, R 2 West, S 2-11,14-17, 21, 28-32; T 26 North, R 1 West, S 1-3, 5-7, 9-12, 14-16, 18, 19, 21-23, 27-29, 32-35; T 26 North, 2 West, S 2, 11, 13, 23-25; T 27 North, R 1 East, S 2-9, 16-20; T 27 North, R 1 West, S 1-20, 22-32, 34-36; T 27 North, R 2 West, S 1-4, 9-16, 21-28, 36; T 28 North, R 1 East, S 4-10, 15-23, 25-35; T 28 North, R 1 West, S 1-36; T 28 North, R 2 West, S 1-4, 9-16, 21-28, 33-36; T 29 North, R 1 East, S 3-10, 16-19, 29-33; T 29 North, R 1 West, S 1-36; T 29 North, R 2 West, S 1-4, 9-16, 21-28, 33-36; T 30 North, R 1 East, S 17, 18, 20, 28, 29, 32, 33; T 30 North, R 1 West, S 4-9, 16-22, 26-35; T 30 North, R 2 West, S 1, 12, 13, 23-25, 27, 28, 33-36; and T 31 North, R 1 West, S 31-33. The temporary franchise would be for a six month period during which Wave would purchase the existing facilities owned by Broadstripe, LLC and negotiate a new franchise with Jefferson County.
